# SWIMMING LESSONS

According to the CDC children ages 1-4 who participate in formal swimming lessons are 88% less likely to drown. Let us help your children learn to be safe and strong swimmers! #### **Group Lesson Session Dates:**

Session 1 June 3-June 13 Session 2 June 17-June 27 Session 3 July 8-July 18 Session 4 July 22-August 1

The second Friday of each session will only be used for makeup classes in the event of a full class cancellation.

**Group lessons** are participation based. Classes will only run if there are at least 3 swimmers registered for each full session. If the class you register for does not run due to low enrollment you have the option of



applying your enrollment to a future session, receiving 2 vouchers for free private lessons or a refund. The vouchers are good for 1 year and can be redeemed at Splash Swim School OR Foothills Green.

Classes run between 9:00am and 11:00am each session. Specific class times are set prior to each session. You will be notified of your specific class time(s) no later than the Saturday prior to each session.

Private and semi-private lessons are also available. These are 1:1 or 2-3:1 lessons that are scheduled at your convenience. They are guaranteed to run. You choose the time, you set the goals and we take it from there! Please speak with the pool manager to schedule lessons.

## SWIMMING AND SAFETY

Drowning remains the second leading cause of accidental death for children ages 1-14 in the United States.

Although our lifeguards are provided to assist you with supervising your swimmers, please remember that you are ultimately responsible for the safety of your family and your guests. There is no substitute for your ACTIVE SUPERVISION!

Swimmers who are dependent on floatation devices to swim must be accompanied by a guardian who is in the water within one arms reach, ACTIVELY WATCHING THEM. We strive to promote

pool safety and prevent accidents around your facility through active supervision, facility safety checks, safety education, swimming lessons and enforcement of pool rules. It is only through a partnership between your family and the Splash staff that we are able to maintain a safe, relaxing and enjoyable environment for your family and guests.

## **POOL RULES**

YOUTH POLICY: According to pool guidelines, members may use the pool unaccompanied by a guardian IF they are 8 years old AND can pass a swim test conducted by the staff. Guardians of

children under the age of 10 must be at least 15 years old.

- 1. SWIM AT YOUR OWN RISK
- 2. Members & their guests only. No pets, except service animals.
- 3. A supervising adult must accompany swimmers under age 8.
- 4. In order to stay at the pool without adult supervision, swimmers who into the arms of another swimmer in the water. are 8 years of age or older must pass a swimming test administered by 16. Horseplay, including dunking and chicken fighting, or any other a lifequard.
- 5. A non-swimmer using a flotation device must remain within arms length of a supervising adult at all times.
- 6. Only swimmers under the age of 6 are permitted in the wader pool. only. Swimmers who are not toilet trained must wear approved "swimming diapers" in both pools.
- 7. In order to swim in the pool, you may not have skin diseases, sores,

colds or other infections.

- 8. No glass containers or sharp objects on pool property.
- 9. No smoking, alcohol, drugs or weapons. Zero tolerance policy strictly enforced.
- 10. No food or gum is allowed in the pool.
- 11. No running.
- 12. No diving in the shallow area (water less than 5 ft. deep)
- 13. Flipping off the side of the pool is not permitted.
- 14. No jumping feet first onto floats, or doing flips off floats. Floats are not allowed in the diving well.
- 15. Diving board users must know how to swim. Divers may not jump
- inappropriate or offensive behavior is not permitted on pool grounds. 17. Profane language is prohibited.
- 18. Pool phones are to be used for emergencies and pool information
- 19. Metal hair clips are prohibited.

Please do not distract the lifeguards while they are on duty. The lifeguards are the final authority and may ask members and their guests to leave if they do not comply with the pool rules.

# **POOL PARTIES AND GUESTS**

Your extended family and friends are welcome to enjoy the benefits of Foothills Green Pool with you! Each membership comes with 25 free guest passes. Additional guest passes may be purchased for \$2.00 each. These passes will be tracked through the computer check in system and billed to you at the end of each season. You are permitted to bring up to 6 guests to the pool without prearranging through the pool manager. If you plan on having more than 6 guests please contact the pool manager at least one week in advance of your gathering to ensure adequate staffing. If additional guards are required, the cost will be charged to you at a rate of \$25/guard/hour.

Guests must be accompanied by a member at all times. Please make sure your quests understand and abide by all pool rules. Please remember that you are ultimately responsible for your family's guests. Children's guests sent to the pool without an adult will need to pass a swim test administered by the lifeguards.

The pool can be reserved any night of the week, with the exception of Thursday nights, from 7:30pm-10:30pm for private events. Please schedule your event with the pool manager at least 1 week prior to the event. Fees to reserve the pool include: \* \$50 deposit check written to Foothills Green HOA

\* At a rate of \$25/Lifeguard/Hour, a minimum of 2 lifeguards are required for each party up to 15 guests, 3 lifeguards are required for 15-50 guests, and from there an additional lifeguard is required for each additional 25 guests. Those details will be worked out with management at the time of booking. Checks should be made payable to Splash Pool Services, Inc.

## INCLEMENT WEATHER AND LIGHTNING

If the outside temperature is below 65 degrees the pool will be closed and the lifeguard will leave the facility (no lifeguard on duty). A sign will be posted on the gate to inform members of the closure. Follow us on Facebook and Instagram to stay current on pool closures.

In the event of a thunder and/or lightning



storm, the lifeguards will adhere to the National Lightning Safety Institute policy & require all swimmers to exit the water AND pool grounds for 30 minutes after the last sound of thunder.

If the storm hinders swimming for 60 minutes, or if the bottom of the pool cannot be seen due to heavy rain, the pool will close until the storm has subsided.
